Tithe - March 2021

"Through tithe, all US Habitat organizations are able to participate fully in building Habitat's vision of a world where everyone has a decent place to live." In FY20, US affiliates tithed more than \$10.7 million worldwide to support Habitat's global work! Tithe was especially important in light of the COVID-19 pandemic and in providing response to disasters such as monsoon repair in Bangladesh, tropical storms cleanup in Guatemala and El Salvador, and earthquake response in the Philippines.

International Housing Need

- 1 in 4 people in the world need decent housing.
- World Health Organization: those living in poor conditions "are exposed to greater personal and environmental health risks, are less well-nourished, have less information and are less able to access health care."
- United Nations: estimates that more than 10 million people worldwide die each year from conditions related to substandard housing.

Habitat's Lasting Impact

- Families living in the more than 5,000 homes built by Habitat India in the rural interior of Maharashtra have reported a higher standard of living and lower medical bills thanks to less exposure to weather, insects and predators.
- 86 percent of Cambodian homeowners report that their children are now able to study at home. 69 percent of families report increased income, with 123 families starting their own micro-businesses.
